- 1 This auction is being held on behalf of Governor of H.P.
- 2 It is presumed that the bidder(s) has/have inspected the vehicle and have satisfied himself/themselves with regard to the condition of the vehicle and no objection, whatsoever will be entertained about any defect, deficiency or unsoundness etc of the Vehicle .
- 3 The sanctioning authority reserves the right to reject any or all the bids without assigning any reason for doing so. It shall not bind itself to accept the highest or any bid. It may also relax any condition of auction at its discretion.
- 4 The vehicle will be allowed to remove from the premises of CPD IDP Solan HP at Solan when the sanction from the competent authority is received. Mere being the highest bidder does not confer any right what so ever arising as a result of this auction.
- 5 No telegraphic offers, private offers and offers made otherwise than at auction place in person shall be considered.
- 6 No person shall be allowed to bid for this Vehicle at their option unless he has signed the conditions of sale in token of his agreement to abide by them.
- 7 No person shall be allowed to bid on behalf of another person or firm unless he produce before the auctioning authority a power of attorney executed by such person or firm empowering him so to act, and in case of firm a certificate of registration of the firm of which he claims to be partner.
- 8 All bids offered in the auction are subject to the sanction of the competent authority. The successful bidder will be required to pay the total amount of bid (sale price) and GST etc.
- 9 Road tax if any payable after the sale will be paid by the highest bidder if the sale is sanctioned in his favour.
